



Nevada Gun Control Question 1: The Californication of Nevada

NEVADA GUN CONTROL QUESTION 1 is the latest and most comprehensive attempt to restrict the rights of law-abiding Nevadans.

Former NYC Mayor Bloomberg is using his billions to bankroll the gun control initiative on the November ballot in Nevada. His plan? Turn Nevada into the next gun-free zone with California and NYC-style gun control measures.

Nevada Question 1 will cost you your money and your freedom

NEVADA GUN CONTROL QUESTION 1 is a poorly written initiative that serves as back-door to increased government regulations and fees. If passed, virtually every "transfer" of a firearm in Nevada would be subjected to federal record keeping. Question 1 is a big-brother initiative. It is not about guns, it's about control.



QUESTION 1 Does Nothing to Stop Criminals from Obtaining Guns

If passed, Question 1 would criminalize private transfers and ensnare law-abiding citizens without preventing criminals and dangerous people from obtaining firearms.



QUESTION 1 Criminalizes "Transfers" and Loans Between Family & Friends

As a general rule, it would apply to all private transfers, not just sales. The simple act of handing a firearm to another person without a background check would be illegal. The overbroad nature of this initiative would criminalize common transfers that take place as part of hunting, recreational shooting, and even self-defense.



QUESTION 1 Criminalizes Commonplace Practices of Law-Abiding Hunters

A hunter could temporarily transfer a firearm to another fellow hunter as long as the recipient is in an area where it is legal to hunt and they possess the proper tags and licenses. This narrow exception could mean that a recipient is in violation of the law and could be subject to penalties if they possess the firearm while traveling to their legal hunting destination, unintentionally moves into an area where it is not legal to hunt, or if the recipient stops in town for lunch or on the side of the road to fix a flat tire.



QUESTION 1 Criminalizes Common Practices of Recreational Shooters

The initiative language does not define an "established shooting range." This could make exchanging firearms between friends or family illegal while shooting at many ranges in Nevada. Many hunters and target shooters in Nevada shoot on that state's approximately 48 million acres of federal BLM land. Borrowing a gun to shoot on that land could make you a criminal because it is not "an established range."



QUESTION 1 Criminalizes Commonplace Practices of Law-Abiding Citizens Exercising Their Second Amendment for Self-Defense

You can't loan a handgun to a neighbor or cousin for protection – unless you go back to the gun store and go back through the red tape. A victim of stalking or domestic violence, who cannot afford to purchase a firearm for self-defense, would be prohibited from borrowing a firearm from a friend until the very moment an attacker is standing over them with a deadly weapon.



Question 1 Turns Law-Abiding Citizens into Criminals

Violating gun control initiative carries stiff penalties. Any transferors who do not comply with these requirements could be charged with a gross misdemeanor and upon conviction would face up to 364 days in jail and a fine of up to \$2,000 on a first offense. Second and subsequent offenses would be punished as a category C felony, which carries a potential punishment of up to five years in prison and a \$10,000 fine.



Question 1 Wastes Law Enforcement Resources & Taxpayer Money

The initiative is an unenforceable, unfunded mandate that will only divert law enforcement's already scarce resources and likely result in a substantial tax increase.



Question 1 Is Intentionally Vague and Misleading

Don't be fooled. This initiative is more than just a background check bill – it has nothing to do with a "Safer Nevada" or addressing crime. Hidden within its intentionally vague and misleading language is a callous attempt to restrict the rights of all law-abiding Nevadans and unknowingly turn them into criminals.
